



## **Mount Pearl Minor Hockey Association 2022**

### **Format:**

The tournament will consist of the following divisions: U11A and U11B; U13A and U13B, U15A and U15B. We are pleased to have the Girls U13AAA and Girls U15AAA teams joining the U13B and U15B divisions respectively. Each division will have 6 teams. Each division will play four teams against teams within their division. The top three teams will proceed to a championship round. 2nd and 3rd place will play in the semi finals on December 30. The 1st place team from the round robin will receive a bye to the final and play the winner of the semi final on December 30.

Each team is guaranteed 4 games. For U13A and U15A, games will consist of two, 12-minute periods and a 15-minute third period. There will be no floods during the game. There will be a flood after each game. For all other divisions, games will consist of three, 10-minute periods.

The usual tie-breaking procedures will be used for placement after the round robin (e.g., Points (2 points win, 1 point tie, 0 points loss), record against tied team, goals formula in HNL rulebook)).

## **Playing Rules**

The tournament will follow the DJHL rules.

In the Round Robin, ties will be permitted. In the semi-final and final games, ties will be broken by a five-minute, sudden death, 3-on-3 overtime period. Should the two teams still be tied after this, the game will be decided by a three-person shootout. If the game is still tied after this, a sudden death shootout will occur. Every player must shoot once, before they can be used again in the shootout.

Teams must play with the roster that they use for DJHL play. Limited substitutions (e.g., 1-2 players) are permitted for injuries, illness, or other circumstances. Such substitutions must be approved in advance by Mike Kelly (DJHL rep).
